

ORDINANCE NO. 11-05

AN ORDINANCE EXPRESSING THE INTENT TO ANNEX A PORTION OF A CORRIDOR OF HIGHWAY MORE SPECIFICALLY A PORTION OF KENTUCKY HIGHWAY 1247 TO THE CITY OF SCIENCE HILL, KENTUCKY.

BE IT ORDAINED BY SCIENCE HILL CITY COMMISSION OF THE CITY OF SCIENCE HILL KENTUCKY:


That the City of Science Hill Kentucky does hereby express his intent to annex to the City of Science Hill Kentucky, pursuant to KRS 84A.420, the following boundary of unincorporated territory which is a right-of-way/corridor known as Kentucky State Hwy 1247.



EXHIBIT "A"

City of Science Hill, KY. Annexation Ordinance No. 05

A certain tract or parcel of land located in Pulaski County Kentucky lying adjacent to the City of Science Hill City Limits and is more particularly described as follows:

The following description was prepared by Jody Dagley PLS 3138 of JD Land Surveying, Inc. Description was prepared utilizing record information from the Pulaski County Court Clerk's office, in Somerset, Kentucky, Department of Highway plan sheets and existing pavement shots using GPS, and noted on attached plat. The purpose of this survey is to delineate the limits of the annexation. It does not in any way reflect a determination of the individual parcel boundaries and should not be used for this purpose.

DESCRIPTION

Beginning at a 2-1/2" galvanized steel fence post located on Hwy 1247 and Hwy 27 and steel fence post having a Kentucky state plane single zone N 3,579,802.686; E 5,247,532.951; Thence severing Hwy 1247 right-of-way N 08°56'43" W a distance of 275.74' to a point; Thence N 20°10'11" W a distance of 129.60' to a point; Thence N 30°11'47" W a distance of 141.50' to a point; Thence N 36°35'36" W a distance of 271.01' to a point; Thence with Norfolk Southern Railroad N 30°34'22" W a distance of 1,050.25' to a point; Thence N 30°55'18" W a distance of 3,599.93' to a point; Thence N 28°52'14" W a distance of 142.13' to a point; Thence with a curve turning to the right with an arc length of 312.86', having a radius of 1,166.98', and a chord bearing of N 21°11'46" W, with a chord length of 311.92' to a point; Thence S 77°48'16" W a distance of 18.25' to a point; Thence continuing in part with Norfolk Southern right-of-way and property owners with a curve turning to the right with an arc length of 573.78', having a radius of 1,186.00', and a chord bearing of N 01°39'51" E, with a chord length of 568.20' to a point; Thence N 13°57'42" E a distance of 377.93' to a point; Thence with a curve turning to the right with an arc length of 654.07', having a radius of 5,770.00' and a chord bearing of N 17°36'54" E, with a chord length of 653.72' to a point located in the Science Hill City Limits located on the west right-of-way 40.0' from center; Thence with City and crossing Hwy 1247 S 84°44'28" E a distance of 83.11' to a point located in the east right-of-way, having a Kentucky State Plane Single Zone N 3,586,490.733; E 5,245,017.619; Thence with east right-of-way and property owners with a curve turning to the left with an arc length of 667.35', having a radius of 5,690.00', and a chord bearing of S 17°43'39" W, with a chord length of 666.97' to a point; Thence S 13°57'49" W a distance of 379.03' to a point; Thence with a curve turning to the left with an arc length of 563.65', having a radius of 1,106.00', with a chord bearing of S 00°57'04" W, with a chord length of 557.57' to a point; Thence S 76°21'04" W a distance of 21.06' to a point; Thence with a curve turning to the left with an arc length of 272.61', with a radius of 1,126.98', with a chord bearing of S 21°56'48" E, with a chord length of 271.94' to a point; Thence S 28°52'14" E a distance of 141.41' to a point; Thence S 30°55'18" E a distance of 3,599.34' to a point; Thence S 30°34'22" E a distance of 1,048.27' to a point; Thence severing Highway 1247 right-of-way S 36°35'36" E a distance of 271.14' to a point; Thence S 30°11'47" E a distance of 147.24' to a point; Thence S 20°10'11" E a distance of 133.11' to a point; Thence S 33°12'01" E a distance of 245.93' to a galvanized steel fence post; Thence crossing KY Hwy 1247 pavement S 58° 08' 10" W a distance of 152.28' to the POINT OF BEGINNING; Said Annexed boundary having an area of **8.68 acres**
